

Prize Draw for a Jaguar F-PACE SVR!

Terms of Participation

1. The organizer of the prize draw for a Jaguar F-PACE SVR is Fraport AG, 60547 Frankfurt am Main.
2. By taking part in the prize draw, the participant accepts these terms of participation.
3. Fraport AG reserves the right to exclude participants if they violate these terms or provide incorrect or untrue information on themselves.

In such a case, the prize may be retroactively withdrawn and the winner required to return it.

4. Only natural persons 18 or older may take part. Employees of Fraport AG and their close relatives are excluded from entering the prize draw.
5. There is no charge for participating in the prize draw.
6. The “Jaguar F-PACE SVR” prize draw program takes place from midnight (CET) of August 1, 2019 until 11:59 p.m. (CET) of March 31, 2020.
7. There are two possible ways to enter the prize draw:

Version A) Registering for the Frankfurt Airport Rewards program:
The prize draw for the car can be entered online by going to fra-rewards.com/wincar and clicking the “Register now!” button. Registration for the Frankfurt Airport Rewards program is mandatory for taking part in the prize draw.

Version B) Completing the promotional flyer at Frankfurt Airport:
It is possible to take part in the prize draw by obtaining and completing one of the flyers that are available at Frankfurt Airport and then making a purchase at any of the 25 HEINEMANN Duty Free shops there. The promotional code printed on the receipt must then be copied onto the prize

draw coupon in the flyer. It is also necessary to provide all of the requested personal data. Consenting to receive advertising is not mandatory. The flyer can then be dropped in one of the prize draw boxes in the shop or mailed to Fraport AG, Retail & Properties (HVM-R), 60547 Frankfurt, Germany.

8. Only the prize specifically described in the prize draw can be won. Images used in the accompanying advertising serve only to illustrate it and do not justify any legal claims or entitlements. It is not possible to receive the cash value of the prize, substitute another prize for it, exchange it, or have its value credited toward other purchases.
