

Conditions of participation

1. Subject of the Conditions of Participation and Organiser

These conditions of participation regulate the conditions for participation in the competition as well as any necessary transfer of rights. The description and the procedure of the respective competition shall take place within the framework of the respective competition campaign on the homepage of the organiser www.andersen-shopper.de.

The organiser of the competition is Andersen Shopper Manufaktur, Christa- u- Günter Andersen Weg 1, 24986 Satrup / Mittelangeln.

By participating in the respective competition, these conditions of participation are accepted.

2. Participation

Participation in the Andersen Shopper Manufaktur competition, hereinafter referred to as the organiser, is free of charge and is governed exclusively by these conditions of participation.

In order to participate in the competition, it is necessary to fill in and send the participation form on www.andersen-shopper.de. Participation by post is not possible.

Participation is only possible within the participation period via the participation form.

Participation in the competition is possible from 27.10.2023 to 31.03.2024. Within this period, users will be given the opportunity to participate in the prize draw.

3. Eligibility

Participation is open to natural persons who have reached the age of 18. Participation is not restricted to customers of the organiser and is not dependent on the purchase of goods or services.

Should a participant be restricted in his/her legal capacity, the consent of his/her legal representative is required.

All persons involved in the conception and implementation of the competition and employees of the organiser and affiliated companies as well as the relatives of such employees and their relatives are not eligible to participate in the competition.

Participation with fake identities or with identities of third parties is not allowed.

Only one submitted registration per participant will be entered into the competition. It is strictly prohibited to use multiple addresses or profiles to increase the chances of winning.

In addition, the organiser reserves the right to exclude persons from participation at its own discretion if there are justified reasons. Such reasons exist in particular in the case of:

- Manipulation in connection with access to or implementation of the competition
- Violations against these Conditions of Participation
- Acting unfairly or
- False or misleading information in connection with participation in the competition.

If the excluded participant is a winner who has already been drawn, the prize may be subsequently withdrawn.

4. Winnings, notification of winnings and transmission of the winnings

The prize will only be handed over to the participant who has won or to the legal representative of the legally incapacitated participant. An exchange, a transfer, a self-collection as well as a cash payment of the prize are not possible.

Any costs incurred for the shipment of the prizes will be borne by the organiser.

The risk is transferred to the participant when the prize is handed over to a transport person. The organiser is not responsible for delivery damage.

Any additional costs associated with claiming the prize shall be borne by the participant who has won. The participant who has won is responsible for any taxation of the prize.

If the participant who has won does not respond after two requests within a period of 3 weeks, the claim to the prize expires. In this case, the organiser is entitled to hold a substitute draw and then transfer the prize to another participant.

5. Termination of the competition

The organiser reserves the right to prematurely terminate the competition in whole or in part or to change its course at any time, even without observing deadlines and without prior notice and without giving reasons, if it is not possible for technical reasons (e.g. computer virus, manipulation of or errors in software/hardware) or legal reasons to guarantee that the competition will be carried out properly and according to plan.

6. Data privacy

Participation in the competition requires the provision of personal data. The participant assures that the personal data provided by him/her, in particular first name, surname, e-mail address, postal address and date of birth are true and correct.

The organiser is responsible for the collection, processing and use of personal data of the participants. The organiser will use the participant's personal details and other personal data only within the framework of the statutory provisions of data protection law. The organiser points out that all personal data of the participant will neither be passed on to third parties nor made available to them for use without their consent.

The organiser will only store, process and use the information insofar as this is necessary for the implementation of the competition or if the participant has given his/her consent. After the end of the competition, the personal data of the participant will be deleted by the organiser.

The participant's personal data will not be used for advertising purposes.

7. Applicable law

Any questions or complaints in connection with the competition should be addressed to the Promoter.

The competition of the organiser is exclusively subject to the law of the Federal Republic of Germany. The legal process is excluded.

8. Salvatory clause

Should any provision of these Conditions of Participation be or become invalid in whole or in part, this shall not affect the validity of the remaining provisions of these Conditions of Participation. Instead of the invalid provision, the legally permissible provision that comes closest in economic terms to the meaning and purpose expressed in the invalid provision shall apply. The same shall apply in the event of a loophole in these Conditions of Participation.
