CONDITIONS OF PARTICIPATION

- for competitions on the domain nissincupnoodleswin.com -

The following Competition Terms and Conditions apply to competitions hosted by the domain nissincupnoodleswin.com (hereinafter referred to as the "Organiser Domain"), which is organised by Nissin Foods GmbH, Ginnheimer Str. 6, 65760 Eschborn (hereinafter referred to as the

“Organiser”).

For reasons of better readability, the following terms and conditions use gender-neutral language to apply equally to all genders.

1 Prizes, entry period and method of awarding prizes

Additional information on the type and scope of the prizes, entry deadlines and the method of awarding the prizes can be found in the competition announcement made by the competition Organiser. The Organiser uses the service provider HAPPY Marketing Solutions AG for the technical processing of the competition.

2 Eligibility

2.1 Only people who are over the age of 18 at the time of entry, who are permanently resident in Germany, France, Denmark or the Netherlands, and who enter from a location within Germany, France, Denmark or the Netherlands are eligible to enter.

2.2 Employees, authorised representatives of the Organiser and their respective family and household members are not eligible to participate.

3 Participation

3.1 Participation in the competition is free of charge.

3.2 Each participant may only enter the competition once. Participation in the name of third parties or participation via “straw men” is not permitted. The winner is solely responsible for the payment of any applicable taxes. The Organiser will pay the tax on winnings for winners resident in Denmark.

3.3 Entry via the Internet is subject to corresponding online registration and selection of one's favourite flavour from the specified Nissin Noodle Cups or Nissin Noodle Cups Soba. In order to enter, entrants must visit the dedicated website for the competition, select their favourite flavour,

and enter their personal details (first name, surname, and address) so that, in the event of a win, the details can be compared with the proof of identity (passport or identity card) that will then need to be submitted. Those who register correctly will be entered into the final draw.

3.4 Each participant can only be registered and drawn once.

3.5 The decisive factor for an eligible entry is timely receipt by the Organiser domain. The entry deadline for the first day of the draw can be found in Section 4. Entries received after this final date will not be entered into the competition.

3.6 If one or more drawings have already been made at the time of initial activation, there is no retroactive claim to a prize.

4 Entry period, prize draw and prizes

4.1 The start date of the competition is October 1st 2024.

4.2 The closing date for entries is March 31st 2025. For registration deadlines, see Section 3.5.

4.3 The draw date for prizes is April 1st 2025.

4.4 There will be several prizes in the draw as per the offer. See the list below:

Draw date April 1st 2025:

4.5 The winners will be determined by drawing lots from among the participants who have duly registered by the draw date.

5 Notification of participants, winners and prize payment

5.1 All participants who have registered on the Organiser Domain with

their e-mail address will be informed of the draw outcome by e-mail within 3 working days after the draw.

5.2 The winners will be notified by the Organiser or the Service provider.

5.3 All winners must contact the Organiser within one week of being notified of the draw (see Section 5.1), stating their surname, first name and address. They must then prove their identity by presenting a copy of a valid passport or identity card.

5.4 Prizes will be delivered to the address provided by the winner within 28 days of the date of notification of the prize. For prizes in the form of travel, the winner will receive the necessary information after contacting the Organiser. The winner will then be contacted by a travel agent for further planning of the trip.

5.5 The Organiser shall not be liable in the event of damage or loss caused by the incorrect or inaccurate provision of addresses by the Participants.

5.6 The Organiser reserves the right, in its sole discretion, to choose the most appropriate method of shipment. The Organiser shall not be liable in the event of any customs duties incurred as a result of the receipt of the Prize.

5.7 In the event of acceptance and later non-departure for reasons for which the Organiser is not responsible, the prize shall be deemed to have been awarded. The winner has no further claims.

5.8 The prizes offered depend on the competition.

5.9 The winner will be announced on the Organiser's website in a manner that is not readily identifiable (e.g. with the first name and initial of the last name). Further publicity, possibly also with a photo of the winner, will only take place in the event of the winner's express consent, which the Organiser will ask for in due course if required. Granting consent is at the winner's free discretion.

6 Cessation of the right to the prize

If a winner is unable to accept the prize or does not respond within the specified time period, they will be disqualified, and the prize will be offered to an alternate participant.

7 Limitations on prize entitlement and taxes

The claim to the prize is not transferable to third parties. The claim to receive the prize by way of cash proceeds is excluded. The winner is responsible for any taxes that may be due, insofar as this is a tax claim by the tax authorities.

8 Rules of conduct, disqualification, and suspension

8.1 The Organiser or its Service Provider has the right to exclude participants from the competition who influence the entry process in a way that is contrary to good faith, e.g. by manipulating the software or by violating the rules of the game, or whose behaviour otherwise exceeds the limits of reasonableness, e.g. by threatening or unreasonably harassing (insult, defamation, extreme call accumulation in the form of "telephone terror", etc.) employees of the Organiser or its Service Provider.

9 Termination/amendment options

9.1 The Organiser reserves the right to cancel or terminate the Prize Draw at any time without notice where there is a legitimate interest in doing so. The competition may be cancelled in whole or in part (for example, for certain prizes or special draws) after a daily draw and allocation of prizes. In particular, this applies if the draw cannot run as planned for any reason, such as computer viruses, software and/or hardware errors and/or other technical and/or legal reasons that affect the administration, security, integrity and/or regular and proper conduct of the draw.

9.2 The Organiser reserves the right to restrict the accessibility of the Organiser domain, especially in the case of technical reasons (e.g.

maintenance and servicing) or to suspend it for a temporary period.

10 Legal action

This competition is governed by German law. In the event of a dispute, participants are entitled to the protection of their rights in accordance with national consumer protection laws.
